The Bloomfield Borough Water Authority held their monthly meeting on November 25, 2025 at the Borough Building. The following were present: Larry Weller, Alex Bender, Chuck Sheaffer, George Dorundo, Jim Swenson, Jerry Philpott, Pete Fleszar, Larry Fisher, Stone Caldwell, and Denice Fisher.

The meeting was called to order by Chairman, Larry Weller at 7:00pm.

The minutes of the October 28, 2025 meeting were approved on a motion of George, seconded by Chuck. Motion passed.

The Financial Report was distributed to all members by Denice Fisher. The detailed report is attached to the minutes. There was a motion made by Chuck, seconded by George to approve the financial report and to approve paying the bills. Motion passed.

There was a motion made by Chuck, seconded by Alex to reappoint James Swenson as Member of the Board for another term. Motion passed. Denice will pass his name on to the Borough for their approval.

Jerry Philpott, solicitor, said for the PennDOT Maintenance Facility the Board approved the calculations Pete did for the last meeting. Jerry gave the Board a draft agreement for their review. The basic agreement came from DGS. There was a motion made by George, seconded by Chuck to approve the numbers in the agreement for Project No. 251-54 Phase 1 Utility Agreement. Motion passed. A motion was made by Jim, seconded by Chuck to accept and approve Project No. 251-54 Phase 1 Utility Agreement. Motion passed. Jim asked about who was going to provide the water meter. The water meter is being provided by the Water Authority at PennDOT's expense.

Jerry provided the Centre Township water service agreement to the Board Members for their review. Pete suggested that businesses be included along with residents in the agreement. A motion was made by Chuck, seconded by Alex to approve the water service agreement and forward the agreement to Centre Township's solicitor. Motion passed.

For Aishel Development, Pete has nothing to report.

For the LSA Grant, Denice has submitted the grant.

Larry said that SCADA is not gathering information properly. Brian Hibshman gave him a quote to see if he could figure out what is going on with the system. The quote is a \$1,000. In the meantime, Larry found that if he restarts the computer every so often the SCADA gathers the information properly. He will have to do the restart when Well 3 is not running. He talked to CS21 and Brian Hibsham and they both can't confirm that this would work.

He called Grosser's Excavating about the lead service lines to try to get a cost for hydrovacing the curb stops. We have nine more years to complete the service lines. Justin said that one curb stop for both sides is \$308, but if you rent the truck for a one 8-hour day, it would cost \$1,600. It is possible to do 28 holes in one day if you have good soil conditions. After the soil is cleared away, you take pictures of the pipe. If the pipe is other than copper, you can apply at PennVest for a grant. A motion was made by Jim, seconded by George, to schedule Grosser's Excavating to come for one day to see how many curb stops they can hydrovac. Motion passed.

Denice handed out the budget for 2026. A motion was made by Alex, seconded by Jim, to approve the 2026 budget. Motion passed.

For gWorks, Denice said that the billing program has been put off going live until December 4<sup>th</sup>. There are still a few issues that are not fixed and she doesn't want to go live until they are resolved.

There being no further business, a motion to adjourn at 7:42pm was made by George, seconded by Chuck. Motion passed.
