#### **RESOLUTION 2-2018**

AMENDING RESOLUTION 5-2008 OF THE BOARD OF SMITHFIELD SEWER AUTHORITY ESTABLISHING RATES FOR THE USE OR AVAILABILITY OF USE OF THE SEWER SYSTEM AND ADOPTING APPROPRIATE REGULATIONS WHICH SHALL INCLUDE THE ACTIONS AND AUTHORITY OF THE AUTHORITY TO COLLECT UNPAID AND DELINQUENT SEWER RENTS AND CHARGES IMPOSED BY THE RESOLUTION INCLUDING THE SHUTTING OFF OF WATER TO THE IMPROVED PROPERTY FOR FAILURE TO PAY SUCH RENTS AND CHARGES.

AND NOW this 9th day of April, 2018, the Smithfield Sewer Authority hereby enacts an amendment to Authority Resolution 5-2008 by adding paragraph C to Section 7, Collection of Unpaid Charges, as follows:

"C. In addition to the provisions of paragraphs A and B set forth above, the Authority shall take whatever action is necessary, to the extent permitted by law, to collect any sewer rates, rents, and other charges which shall be delinquent in cooperation with the Brodhead Creek Regional Authority, or the PA American Water Company that provides water service to certain improved properties also receiving sewer service from the Authority, which shall result in the shutting off of said water service of the Brodhead Creek Regional Authority, or the PA American Water Company to these properties, until any and all such delinquent sewer charges are paid in full to the Authority."
