Monitoring Requirements Not Met for Ralston Area Joint Authority

Our water system violated several drinking water standards over the years. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards.

What should I do?

There is nothing you need to do at this time.

The table below lists the contaminants we did not properly test for during the last year, the required sampling frequency, how many samples we took, when samples should have been taken, and the date on which corrective action samples were (or will be) taken.

What happened? What was done?

We were required to monitor for distribution chlorine residual during the week of 3/31/24 – 4/6/24. We failed to monitor and report during the required time frame but monitored late the following week and therefore cannot be sure of the quality of our drinking water during that time.
