Monitoring Requirements Not Met for Ralston Area Joint Authority

Our water system violated several drinking water standards over the years. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards.

What should I do?

There is nothing you need to do at this time.

We were required to monitor for TTHM / HAA5 during the week of 9/12/21 – 9/18/21 and sampled outside of that time frame on 9/10/21 therefore cannot be sure of the quality of our drinking water during that time.
