WHEREAS, pursuant to the provisions of National Pollutant Discharge Elimination System (NPDES) Permit No. PA PA0022209, the MUNICIPAL AUTHORITY OF THE BEDFORD BOROUGH (MABB) is subject to the United States Environmental Protection Agency (USEPA) Industrial Pretreatment Program requirements.

THEREFORE, the below noted amendment shall be adopted as part of the Industrial Pretreatment Program.





A 30 day extension may be granted at the Authority's discretion to a customer receiving an NOV. Please note that the original timeline of established assessments shall not be altered if failure to comply with the NOV occurs, therefore, if an extension is granted prior to the exhaustion of the first 30 day period and a Corrective Action Plan has not been received within 60 days since NOV issuance, then an assessment of \$5,000 shall apply and so forth.
