Additional Inspection Fee (when estimated usage date is not met)	Sewer R & R 6.03	Additional inspection fee if applicant for service must provide another estimated usage date when connection is delayed.	\$75.00
Sewer Connection Inspection Fee	Sewer R & R 7.02	Inspection fee per connection per visit paid in advance.	\$75.00
Maintenance & Repair of Sewer Connection Beginning at Property Line	Sewer R & R 10	Property owner bears responsibility for maintenance and repair of sewer connection beginning at property line with limited exceptions. See Section 10 for more detailed description.	Actual Costs of Labor and Materials, except if the Authority performs the work the Authority charges a labor fee of \$75.00 per hour, with a minimum charge of 1 hour (for service between 7 am to 3 pm (M to F)) and \$100.00 per hour, with a minimum charge of 2 hours (for service after 3:30pm and weekends).
