REQUEST FOR SANITARY SEWAGE SERVICE

(To be completed along with Application for Service)

According to the Snake Spring Township Municipal Authority Rules and Regulations Section 6.03 reads as follows:

Each applicant for new service shall place into escrow with the Authority \$100.00 refundable deposit upon the applicant requesting the Authority inspect their sewer connection. At the time of application the applicant shall estimate the time usage of the connection will commence. The \$100.00 escrow will be refunded when written notice of usage is given the Authority, provided notice is received prior to the estimated commencement date. At the time of Authority inspection, a sewer line plug will be installed in the applicants' sewer lateral cleanout nearest the Authority sewer main providing the applicants sewer tap. This plug will remain in place until the applicant provides written notification to the Authority requesting sewer service to commence. Upon notification the Authority inspector will remove the sewer plug permitting sewer service to commence. **This sewer plug is to be removed by Authority inspector only.** If upon inspection by Authority personnel, at any time prior to written notice of usage is received by the Authority, that the sewer plug has been removed, the applicant will be assessed a **\$1,000.00 fee** for removal of the sewer plug. In addition the \$100.00 escrow deposit will be forfeited by the applicant. The Authority reserves the right to pursue any and all balances for applicable fees and usage by the applicant prior to the applicant providing written notice to the Authority or for the period prior to the Authority learning of the applicant's use.

In addition to the above, the Applicant shall notify the Authority office at least 48 hours prior to the time when inspection of a connection is requested, to allow for scheduling of an authority inspector. The inspector must be present to inspect and approve this construction.

Conditions of Application for Sanitary Sewage Service

The applicant agrees to abide by the Operating Rules and Regulations of the Authority. There is a non refundable \$30.00 application fee payable at time of application. All applications are on a first come first served basis. The applicant agrees to pay all required fees (tap and capacity) as applicable within two (2) weeks of approval of the application. If fees are not paid within two (2) weeks of any approval the application is voided. The applicant agrees to commence service for the applied usage within one (1) year from the date of approval by the Authority. Unused tap and capacity fee's will be refunded to the applicant if application is withdrawn by the applicant or if the application becomes void due to service not commencing within one (1) year of application approval. If service does not commence within one (1) year, the application becomes void and must be re-applied for to be considered for service. If the service is re-applied for, the applicant loses the previously held position on any waiting list for service and will be placed on the waiting list as of the re-approval date.

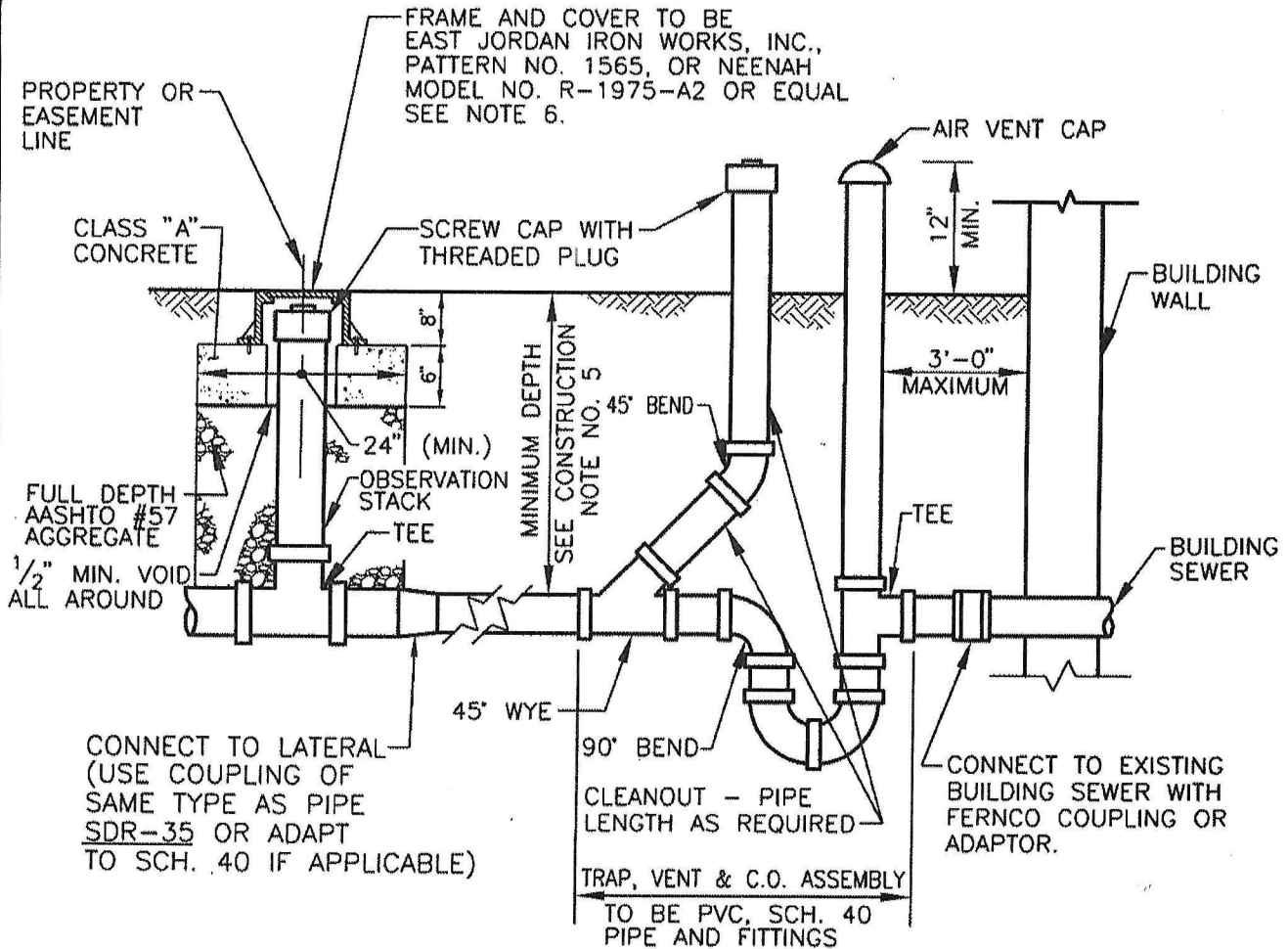

CONSTRUCTION NOTES

1. PIPE AND FITTINGS FOR BUILDING SEWER SHALL BE AT LEAST FOUR (4) INCHES IN DIAMETER. PIPE BEDDING TO BE AS SPECIFIED.
2. PIPE AND FITTINGS OTHER THAN TRAP, VENT & CLEANOUT SHALL BE POLYVINYL CHLORIDE SDR-35 (PVC) PIPE CONFORMING TO ASTM D-3034. SCHEDULE 40, ASTM D-1785 PVC PIPE MAY BE USED IF TRENCH IS NOT WET AND IF APPROVED BY THE AUTHORITY'S INSPECTOR.
3. JOINTS SHALL BE GASKET TYPE, ASTM F-477, FOR ASTM D-3034, SDR-35 PIPE & PURPLE PRIMED, ASTM F-656, AND SOLVENT CEMENTED, ASTM D-2564, FOR SCHEDULE 40 PIPE.
4. BUILDING SEWER SHALL BE LAID ON A GRADE OF NOT LESS THAN ONE-QUARTER (1/4) OF AN INCH PER FOOT TOWARD THE SANITARY SEWER MAIN.
5. PROVIDE A MINIMUM COVER OF TWO AND ONE-HALF (2-1/2) FEET FOR BUILDING SEWER.
6. INSTALLATION OF FRAME AND CONCRETE PAD SHALL BE SUCH THAT NO DOWNWARD FORCES IMPARTED BY A LOAD ON THE FRAME CAN BE TRANSFERRED TO THE OBSERVATION STACK.

SECTION 21 CONNECTION CHARGE

21.01 Tap Fee (Before Sewage System Construction). Upon making application for the issuance of a connection permit a tap fee of Five Hundred Thirty Dollars (\$530.00), imposed by the Authority for collection by the Authority, will be charged for each building unit connected directly or indirectly to the sewer system. If the owner or applicant pays this fee upon notification and before construction of the sewer system begins, said owner or applicant's tap fee shall only be Four Hundred Eighty Dollars (\$480.00). Unless written permission is obtained from the Authority, a separate tap fee will be required for each individual occupied building, whether constructed as a detached unit or as one of a pair or row.

To be in accordance with Pennsylvania House Bill No. 444, any reference to connection fee in prior editions of these Rules and Regulations shall be deemed as the wastewater treatment plant construction portion of the tap fee.

The tap fee after April 6, 1992 shall be as set forth in the current Schedule of Fees and Charges per equivalent dwelling unit (EDU) unless provision for tap has been made by the applicant prior to this edition of the Rules and Regulations.*

21.03 Tap and Capacity fees Along Existing Sewer Lines, Along New Sewer Extensions or in New Developments. Any application for service received after December 31, 1996 for connection to an existing sewer main, a new sewer extension or in a new development will be subject to a sewer tap fee as set forth in the current Schedule of Fees and Charges, and a capacity fee per EDU as set forth in the current Schedule of Fees and Charges, even if a wye or a tee has been pre-set in said sewer main at that location.

A \$1,600.00 capacity fee will be applicable to the Bedford Square Shopping Center subsequent to December 31, 1996.

The capacity fee (as set forth in the current Schedule of Fees and Charges) will also apply to development or subdivisions whereupon the building is determined to be a multiple use unit or a multiple dwelling unit. In such case, the applicant is subject to a capacity fee of ("capacity fee" X "N") where N is the number of equivalent dwelling units (EDU) of the multiple user.

Any development building a sewer extension with the purpose of serving a proposed subdivision will be required to pay all construction and inspections costs in addition to the tap fee and the capacity fee per EDU as set forth in the current Schedule of Fees and Charges. **
