

WATER SYSTEM INFORMATION:

This report shows our water quality and what it means. If you have any questions about this report or concerning your water utility, please contact Richard Motycki at 724-239-2381. We want you to be informed about your water supply. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the second Tuesday of each month at 7:00 P.M. in our office located at 508 Main Street, entering through the rear of the building.

SOURCE OF WATER:

We purchase all our water from the Authority of the Borough of Charleroi. Their source of water is the Monongahela River, a surface water source. The water is treated at their Charleroi Filtration Plant.

A Source Water Assessment of our source was completed in 2002 by the PA Department of Environmental Protection (PADEP). The Assessment has found that our source is potentially most susceptible to accidental spills along the transportation corridor and "wildcat" sewers dumping raw sewage directly to the river and to a lesser degree by industry and storm water runoff from developed areas. Overall, our source has high risk of significant contamination. Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EDUCATIONAL INFORMATION:

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure the tap water is safe to drink, EPA and DEP prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA and DEP regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. OTHER INFORMATION:

The Authority is constantly working to maintain and improve its system. During the year of 2023 we installed 900 feet of new 12" water line on Main Street. Under the Rules & Regulation of the Bentleyville Municipal Authority, all property owners are responsible for the locating of water curb boxes which are to be exposed and accessible at all times, especially in case of emergency. The Authority is NOT responsible for the location of water curb boxes. The property owner will be responsible and bear ALL COSTS for its location.

MONITORING YOUR WATER:

The Bentleyville Municipal Authority and the Authority of the Borough of Charleroi routinely monitor for contaminants in your drinking water according to federal and state laws. The following tables show the results of most recent monitoring required for the period of January 1 to December 31, 2023. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act. The date has been noted on the sampling results table.

SOURCE(S) OF WATER:

Monongahela River

A Source Water Assessment of our source(s) was completed by the PA Department of Environmental Protection (Pa. DEP). The Assessment has found that Monongahela River Intake is most susceptible to accidental spills along the transportation corridor and "wildcat" sewers dumping raw sewage directly to the river. This intake is also susceptible to a lesser degree by industry and storm water runoff from developed areas. Overall, the Monongahela Watershed has a high risk of significant contamination. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently.

DEFINITIONS:

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Minimum Residual Disinfectant Level (MinRDL) - The minimum level of residual disinfectant required at the entry point to the distribution system.

Level 1 Assessment – A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Level 2 Assessment – A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an *E. coli* MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water.

Mrem/year = millirems per year (a measure of radiation absorbed by the body)

pCi/L = picocuries per liter (a measure of radioactivity)

ppb = parts per billion, or micrograms per liter ($\mu g/L$)

ppm = parts per million, or milligrams per liter
(mg/L)

ppq = parts per quadrillion, or picograms per liter

ppt = parts per trillion, or nanograms per liter

DETECTED CONTAMINANTS HEALTH EFFECTS:

<u>Total coliform bacteria</u> are naturally present in the environment and are used as an indicator that other potentially harmful bacteria may be present.

<u>Fecal coliforms and E. coli</u> are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Microbes in these wastes can cause short-term health effects such as diarrhea, cramps, nausea, headaches, or other symptoms. They may pose a special health risk for infants, young children, some of the elderly, and people with severely compromised immune systems.

OTHER VIOLATIONS:

The Authority was found to be in violation of the Monitoring Requirement for Dalapon (SOC) during the calendar year of 2023. Sampling for all 30 SOCs was completed on time in the third quarter of 2023. Analysis results were reported to the Authority on October 13, 2023. The contracted laboratory failed to submit the results for Dalapon to the DEP by the tenth day of the month following analysis as required. Information about Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Authority of the Borough of Charleroi is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Monitoring Requirements Not Met for Dalapon (Synthetic Organic Chemicals, SOCs)

Our water system violated a drinking water standard over the past year. Even though this was not an emergency, as our customers, you have a right to know what happened and what we did to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. The Authority had been required to sample for the SOC Dalapon during the Third Quarter of 2023. SOC sampling was completed by The Authority and sent to the contracted lab for analysis in a timely manner. The Authority received the test results on October 13, 2023 stating that all 30 Regulated SOCs were in compliance with the drinking water standards. Unfortunately, the contracted laboratory failed to submit the results for Dalapon to the DEP. The late reporting resulted in The Authority violating the reporting requirements for Dalapon (SOC).

What should I do?

There is nothing you need to do at this time.

The table below lists the contaminant that we did not properly submit test results for during the previous year. It also includes how often we are supposed to sample for, how many samples we are supposed to take, how many samples we took, when samples should have been taken, and the date on which follow-up samples were taken.

What was done?

On February 13, 2024, the DEP notified The Authority that the SOC testing results for Dalapon were not submitted by the laboratory. The Authority then made contact with the contracted laboratory responsible for analyzing the samples and it was determined that the lab had not submitted the results to the DEP in a timely manner as they were instructed to. The Authority will now be sampling for Dalapon in each quarter of 2024 as directed by the DEP.
