**Violations:** During February of 2022 we monitored for Distribution Chlorine each week but failed to report the results to the PA Department of Environmental Protection by the required due date, resulting in monitoring/reporting violations. In 2022 we failed to submit our Annual Drinking Water Quality Report (CCR). It has been competed in June of 2023.

## Monitoring Requirements Not Met for Rixford Waterworks Association

Our water system violated several drinking water standards over the past year. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 2021 we monitored for Haloacetic Acids but monitored at the wrong sample site resulting in a Monitoring/Reporting violation.

#### What should I do?

There is nothing you need to do at this time.
